**Terms of reference:**

**I. IPR scheme: Applicable to members listed under “A” and “C” only.**

- a. The Chairperson shall invite applications for IPR from the faculty members of Goa University as per the IPR and Patent Scheme.
- b. The Committee shall evaluate applications received under the IPR and Patent Scheme at various levels and submit shortlisted applications every year through DRDRM.
- c. The Chairperson may decide to co-opt additional experts either from members listed in “B-External Experts” or faculty members from Goa University with domain expertise or familiarity/experience in areas related to the creative work for evaluation of the applications.
- d. The Committee shall seek the reports of the proposals sponsored under the scheme every year. The applicants shall be asked to make a presentation of their progress. The reports along with the recommendation shall be submitted to the authority.
- e. To organize a workshop for mobilizing IPR-related research.
- f. Expenditure for holding meetings shall be borne through the grants allocated to the DRDRM.

**II. Goa University Innovation, Incubation and Start-up Scheme (GUIISS)/Hand-holding and Start-ups (DST-PURSE): Applicable to all the members.**

- a. The proposal submitted under GUIISS/Hand-holding and Start-ups (DST-PURSE) shall be examined by the THREE experts specially appointed for each proposal. The pre-evaluation process shall be through an independent process conducted by DI3P. DI3P shall forward the approved list of the proposals along with the comments of experts to the Chairperson (Review Committee). The Chairperson shall consider only this list for the presentation under GUIISS/Hand-holding and Start-ups (DST-PURSE) for evaluation.
- b. The Committee shall evaluate the presentation of the proposals for the innovation and start-up as per GUIISS under Category I and Category II.

- c. The Committee shall prepare separate reports for each Category I and Category II and submit recommendations to support incubation at Goa University Research Park to authority through DI3P.
- d. Committee shall meet TWICE a year in the months of February/August to evaluate all the proposals received under GUIISS.
- e. In case of specially floated schemes/challenges/competition, etc. - like "Hand-holding and Start-ups (DST-PURSE)" the Chairperson can call the meeting for the evaluation of the presentation of proposals with short notice.
- f. Expenditure for holding meetings shall be borne through the grants allocated to the DI3P.

The term of the Committee shall be for a period of three years from the date of issue of this order.
