## C I R C U L A R

As per Goa University Rule R-03, the Goa University Campus Students Union is to be constituted for the Academic Year 2024-25.

The said election process has been scheduled to commence in the third week of August, 2024 in the respective Schools for Post Graduate students on Campus, which includes Election of the Group Representatives and Election of the Executive Body.

The elections for (1) Undergraduate Students on campus (Including all Integrated programmes) Portuguese, French, IMBA (Year I to III), M.Sc.-Integrated (Year I to III), B.Voc., and (2) students engaged in research leading to Ph.D. and other research degrees through the various University Teaching Schools shall be conducted in the 'D' Block as per Annexure 'B' (u) & (v). Other elections shall be conducted in the respective Schools as per Annexure - B.

The Deans may engage the services of the Vice-Deans, Faculty and non-teaching staff of their respective School for the smooth conduct of the election.

The process of receiving the nominations, scrutiny of the nominations, withdrawal and display of final list of eligible candidates shall be carried out by the Directorates office.

The Schools shall carry out the following activities excluding those mentioned under serial No. 1 and 2 above.

- 1. Certification of the nomination forms w.r.t. the bonafides of the candidate, proposer and seconder, age limit of candidate and backlog paper/s of the candidate, if any.**
- 2. Conduct of elections as per scheduled wherever required for various posts.**
- 3. Counting of ballots if election is required to be conducted.**
- 4. Submission of result sheet to the Directorates office.**

The Directorates office will provide all the required stationery including ballot papers, ballot boxes, ink pads, marker sticks, etc. for the election.

The eligibility of the students to vote shall be all students who have enrolled themselves for a Degree courses (including Ph.D.) for the Academic Year 2024-25 as per the voters list. Teachers from the University Schools and Affiliated Colleges pursuing Ph.D. shall have no voting rights. Polling agents/ representatives shall not be allowed for the election except those who are duly authorized as mentioned in the notification. For the scrutiny only contesting candidates are allowed. In the case of a tie, as per SSA-7, draw of lots will be done.

The students of Part-II, S.Y, T.Y and Ph.D. should produce their Goa University Identity Card. The Students of Part-I and First Year (Undergraduate) should produce their fee receipt in case Identity Card is not issued. However, if the Dean/Vice-Dean/Programme Director is satisfied that the students are eligible to vote, they could be allowed to vote provided their names are in the voters list.

The assistance and support of all the schools are sought for conducting the Goa University Campus Students Union election.
