2. The quotation must accompany E.M.D of **Rs.6616.00** in form of DD/DCR of scheduled bank drawn in the favour of Registrar, Goa University payable at Panaji. **The EMD as aforesaid should be enclosed in separate cover and attached to the cover containing the aforesaid quotation.**
3. Security deposit at the rate of 10% of the gross amount of the work shall be deducted from the R.A bills.
4. Terms & conditions for execution of work as per CPWD form 6&7 shall be binding on the bidders.
5. The period for completing the work is 90 days and shall be reckoned from the 15<sup>th</sup> day of issue of the work order.
6. The quotation should be valid for 90 days for acceptance from the date of opening.

7. The defects liability period of the work is 01 year from the date of completion of work. Security deposit will be released after the completion of defects liability period under the terms of clause 17 of contract (CPWD form 7).

**8. Quoted amount shall be exclusive of G.S.T. The G.S.T as applicable shall be paid extra on total cost of the work done.**

9. Self-attested copies of valid PWD Registration certificate, PAN card and GST Registration certificate should be enclosed with this quotation.
