**Terms & conditions:-**

1. The Sealed Percentage rate Quotation superscribed "**Providing Post Construction Anti-Termite Treatment for Faculty Block-D, Goa University**" should reach the office by 11.00 am on 27/01/2025 and will be opened on the same day at 11.30 hrs.
2. The Quotation must be accompany E.M.D of **Rs.860/-** in form of D.D/D.C.R of scheduled Bank drawn in favour of the Registrar, Goa University payable at Panaji. The EMD as aforesaid should be enclosed in separate cover and attached to the cover containing the aforesaid quotation.
3. Security Deposit at the rate of 10% of the gross amount of work shall be deducted from the RA/Final Bill.
4. Terms and conditions for execution of work as per CPWD form 6 & 7 shall be binding on the bidders.
5. The period for completion of work is 30 days and shall be reckoned from 15<sup>th</sup> day of issue of the work order.
6. The quotation should be valid for 90 days for acceptance from the date of opening of the quotations.
7. The defects liability period of work is 05 years from the date of completion of work. Security deposit will be released after completion of defects liability period in terms of clause 17 of contract ( CPWD form 7).

8. The Successful bidder will be required to furnish a Guarantee bond for a period of 05 years from the date of completion of work stating eradication of any termite infestation in the treated area free of cost during the guarantee period.

9. Quoted amount should be exclusive of G.S.T. The G.S.T as applicable shall be paid extra on the total amount of work done

10. Bidders shall enclose self attested copies as below:-

i) Valid Pest Control Licence issued by Government of Goa.

ii) Valid P.F & E.S.I.C Registration.

iii) Work completion certificate or documents showing services of similar works in last three years ending December 2024.

iv) Valid Shop establishment Certificate or Trade licence in relevant trade with the quotation.

v) GST Registration certificate.

vi) PAN Card.
