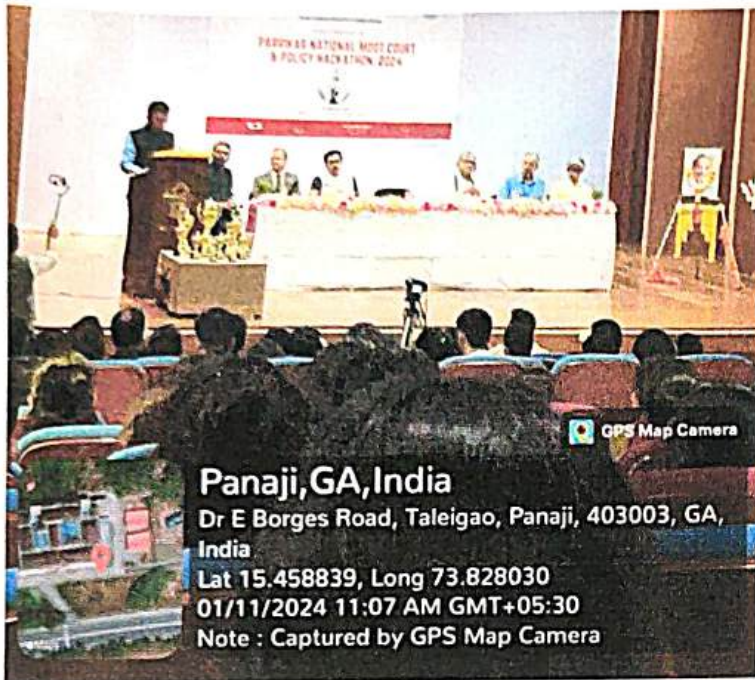

Moot court competitions typically involve participants (law students) presenting oral arguments based on a hypothetical legal case. The case addressed complex legal issues and involve issues of Human Rights.
11. Description of the Program/activity/event	The two-day event commenced with the inaugural session, featuring preliminary rounds 1 and 2, as well as the quarters of the moot court. Day one concluded with a vibrant cultural evening. On the second day, the moot court progressed to the semi-finals and finals. The event reached its culmination with a grand valedictory session.

The program deepens understanding of national laws, prepares for legal practice, recognizes excellence, contributes to legal discourse, prepares for international competitions, and raises public awareness about legal issues.

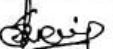
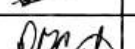
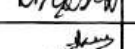
