- 2. The challenge in this petition was to the Goa University's Notification dated 25/07/2023, which had the effect of cancelling the petitioners' admission to the first year in the V.M. Salgaonkar College of Law and directing a fresh common entrance test for the academic year 2023-2024.
- **3.** On 26/07/2023, after this matter was mentioned for urgent hearing, we made the following order:
 - "1. Heard Mr Kantak, learned Senior Advocate, who appears along with Mr A. Kamat, Mr A. Gosavi and Ms Saicha Desai for the Petitioners and Ms. A.A. Agni, learned Senior Advocate who appears with Ms Rajlaxmi Bhatkar for the Respondent-Goa University. Mr Deep Shirodkar, learned Additional Government Advocate, appears for Respondent Nos. 1 and 3.
 - 2. Mr Kantak states that a private notice has been served on Respondent No.4.
 - 3. We grant the Petitioner leave to add Govind Ramnath Kare College of Law through its Chairman of the Managing Committee as Respondent No.5

4. Ms. Agni, learned Senior Advocate for the Goa University fairly

states that the notification dated 25.07.2023 will not be immediately implemented and a further notification is in the process of being issued so that the admitted students can continue to attend the classes of Respondent No.4. The students admitted in Respondent No.4-College and Govind Ramnath Kare College of Law, Margao can attend the classes until further orders.

- 5. Ms Agni further requests that the matter be kept for consideration on 31.07.2023. Accordingly, we post this petition for further consideration on 31.07.2023.
- 6. Mr Kantak states that immediate steps will be taken to serve

Respondent Nos.4 and 5 and even an affidavit of service will be filed. In addition to usual mode of service, private service/humdast is allowed.

- 7. All concerned to act on an authenticated copy of this order."
- **4.** Today, when the matter was called out Ms Agni learned Senior Counsel for the Goa University tenders Notification dated 28/07/2023 issued by the Goa University. This Notification dated 28/07/2023 reads as follows:

In continuation to the above referred Notifications, it is notified that, in view of the communication received from the

Secretary, Education, Government of Goa, the University has decided to cancel the conduct of GU-CLAT 2023 scheduled on 6th August 2023. The Directorate of Higher Education with the assistance of V.M. Salgaoncar College of Law, Miramar and G.R. College of Law, Margao will complete the admission process for the B.A.LL.B Programme for the academic year 2023-24.

Sir,

Please find enclosed herewith approval received from the Bar Council of India to increase 30 seats tor First Year B.A.LL.B. (20 seats in V.M. Salgaocar College of Law, Miramar and 10 seats in G.R. Kare College of Law, Margao) based on the request of the Government of Goa, in order to resolve the First Year B.A L.L.B. admission issue.

In view of the above, you may cancel the scheduled entrance test for first Year B.A.LLB. Admission.

The Directorate of Higher Education with the help of V.M. Salgaocar College of Law, Miramar and G.R. Kare College of Law, Margao will prepare a fresh merit list based on the criteria followed for all these years that is 50% weight-age for 12" examination and 50% weight-age for Goa Common Law Admission Test ("G-CLAT"). Based on the fresh merit list Directorate of Higher Education will admit students, those who have not got admission till date in both the colleges without disturbing the admission of the students, who have already been admitted to the First Year B.A.LL.B class.

This will salve the entire issue without causing any harm to academic interest of any students,
